# ALAMEDA COUNTY WORKFORCE DEVELOPMENT BOARD'S CUSTOMIZED/INCUMBENT WORKER TRAINING PROGRAM CAN HELP YOU TRAIN AND RETAIN YOUR WORKFORCE

#### How does it work?

- ✓ Eligible applicant must be a business;
- ✓ The employer determines if they are looking for new candidates to be trained and hired (customized training) or are upskilling their current full-time, regular employees (incumbent worker training);
- ✓ The employer determines the training needed occupational, educational skills, etc. and the trainer;
- ✓ Employer must meet expected training and placement rates for training participants;
- ✓ Training participants receive an industry-recognized certificate at the completion of training;
- ✓ The employer receives reimbursement at the successful completion of a training;
- ✓ Applicants are approved on a case-by-base basis and through review of past performance.

### WHAT ARE CRITERIA FOR THE INCUMBENT WORKER PROGRAM?

- ✓ Business facility where employees trained must be located in the Alameda County, and in Contra Costa County, or City and County of San Francisco (through December 2021);
- ✓ Business must be stable (have been operating in ACWDB area for 12 months prior to application date);
- ✓ The employer must meet one of the following:
  - Propose an upgrade in employee skills
  - Propose an increase in employee skills and wages
- Propose training in portable skills
- Training is the focus of business retention efforts
- √ Wages of an incumbent worker cannot exceed \$35.11/hr.;
- ✓ The employer must contribute a portion of the cost of training, dependent on size;

### WHAT ARE CRITERIA FOR THE CUSTOMIZED TRAINING PROGRAM?

- ✓ Business facility where employees trained must be located in the Alameda County, and in Contra Costa County, or City and County of San Francisco (through December 2021);
- ✓ Business must be stable (have been operating in ACWDB area for 12 months prior to application date);
- ✓ The employer contributes up to 50% of the cost of training;
- ✓ Training participants must be enrolled in the Workforce Innovation and Opportunity Act (WIOA) program;
