WIOA & ACWDB OVERVIEW

- Federal Workforce Innovation and Opportunity Act (WIOA) Title I program
- Department of Labor Employment and Training Administration
- State of California Employment Development Department
- Alameda County Workforce Development Board one of two state-designated workforce boards in Alameda County

The local system establishes services through front-line service providers to equip Adults, Dislocated Workers, In-School Youth and Out-of-School Youth with career readiness services, career placement, skills training, and other post-secondary options.

WHY THE PROMISING FUTURES PROJECT?

 Addresses unmet needs regarding occupational skills and competencies in key sectors and the attainment of industry-aligned certificates

Pilot best practice strategies

 Empower, equip, and prepare Out-of-School Youth with the tools they need to discover and successfully enter career pathways

PROJECT FUNDING

Up to \$185,000 for out-of-school youth/young adults

12-month cost reimbursement contract

- December 2023 - December 2024

TARGETED POPULATION

The Promising Futures Projects targets Disconnected/Out-of-School Youth/Young Adults ages 16-24, who are not attending school and meet one or more of the following criteria:

- Dropped out of high school
- Basic skills deficient
- Justice system involved
- Foster youth (current or former)
- Pregnant or parenting

- Single spaced
- Pages numbered sequentially
- Not to exceed 15 pages in total (response and attachments)

Required Documents:

- Cover letter (form attached to SFP)
- Proposed program model (responsive to Selection Criteria)
- Program budget and justification (forms attached to SFP)
- Roster of project staff and brief job description for each staff member
- Relevant past projects including WIOA or other workforce development grant experience
- One reference with knowledge of projects/programs similar to the Promising Futures Project
- A checklist is included as a guidepost
