

ITEM VI.A. - DISCUSSION LEGISLATIVE UPDATES

BACKGROUND:

Alameda County Workforce Development Board staff provides legislative updates that may have implications for the local workforce system and give signal to changes needed in future. Staff updates also have the potential to spark new ideas and opportunities to adapt programming and partnerships.

LEGISLATIVE UPDATES:

Senate Bill (SB) 864

SB 864 proposes that the state labor agency and other expert stakeholders develop workplace rights curriculum for delivery to local workforce system job seeker participants. Local workforce boards would be responsible for ensuring the delivery of workplace rights curriculum and the requirement would be instituted/executed through state-required Four-Year Local Plans.

SB 864 has passed out of the Senate and has been referred to the Assembly Appropriations Committee and has a high probability of moving to the Governor's desk for signature.

Senate Bill 382

SB 382 would establish the "California Workforce Pay for Success Program" to better position the state to prepare underemployed, unemployed, dislocated workers, and job seekers with barriers to employment with career advancement opportunities.

SB 382 would require the California Workforce Development Board to develop a selection process for the solicitation of proposals from eligible organizations with the goal of awarding those with proven results and outcomes. This bill has been held in suspense and under submission and will likely not move forward.

Assembly Bill (AB) 1228

AB 1228 authorizes the Fast-Food Council to set fast-food restaurant standards for minimum wage, and develop proposals for other working conditions, including health and safety standards and training. Aligned with this effort includes a wage hike to \$20/hour for the state's 500,000 fast workers, set to take effect in April 2024.

2021 Budget Act Funding - Regional K-16 Education Collaboratives Grant Program

The Bay Area K-16 Collaborative via the Chabot – Las Positas Community College District, received \$18.1M through the state's 2021 Budget Act (Regional K-16 Education Collaboratives Grant Program). The Regional K-16 Education Collaboratives Grant Program brings together

regional networks and industry to provide equitable access to Education, Engineering/Computing, and Healthcare/Biotechnology pathways in the East Bay, San Francisco/Peninsula, and San Jose regions.

The goal of the funding is to remove barriers to degree completion, accelerate transfer success, increase equitable participation in early college credit, and expand work-based learning.

ITEM VI.B. - DISCUSSION

WORKFORCE DEVELOPMENT BOARD RETREAT

The Alameda County Workforce Development Board (ACWDB) convened its most recent retreat in 2021. The event, spanning half a-day, took place virtually and revolved around engaging the board, clarifying committee roles and responsibilities, and formulating a value proposition statement.

In June 2023, the Board Chair, Youth Committee Chair, and staff attended the *Board Development Training: Creating Collective Community Solutions* hosted by the California Workforce Association (CWA). The three core elements of the workshop included creating a workforce board that understands and defines its role within the community, the impact it has on the business and economic growth, and the leadership principles needed to become the foundation for individuals, families, businesses, community organizations and other key stakeholders within a local area. One of key insights from the workshop emphasized the importance of workforce boards to not only have in place local and regional plans but also to develop and implement their own comprehensive strategic plan that leads to community improvement.

One potential approach for ACWDB to initiate the development of a strategic plan would involve organizing a retreat. The Board Chair and staff would like to engage in discussions with the Executive Committee regarding planning a day-long retreat agenda, scheduled in the early fall. The focal point of the retreat would revolve around the board's vision post-pandemic, priorities in alignment with 13 roles and functions of the board, and strategic direction with a community lens. The primary objective of this initial discussion would be to explore possible dates, give staff direction on venue options, and establish a process for crafting a retreat agenda. It is anticipated that the Board's retreat would be facilitated by CWA or another appropriate organization.

By hosting this retreat, it will enable members to collectively collaborate and develop a strategic plan.

ITEM VII.A. – INFORMATION

TELECONFERENCE OPTIONS UNDER THE BROWN ACT

BACKGROUND:

During the COVID-19 pandemic and state of emergency, boards and commissions subject to requirements under the Brown Act were allowed to hold virtual meetings without having to adhere to all Brown Act requirements. In October 2022, County Counsel notified Alameda County boards and commissions of a new bill signed into law in September, AB 2449, which provided for meetings subject to Brown Act with long-term permissions to hold virtual meetings without having to give the public access to private locations, subject to certain restrictions.

At the December 2022 Board meeting, the Director informed board members of these impending changes that would be in effect January 1, 2023, and once the statewide state of emergency was lifted. In preparation for these new meeting requirements and allowances, Alameda County Workforce Development Board (ACWDB) staff have been actively pursuing upgrades to the technology for use at the current standard meeting room to facilitate hybrid meetings.

New Brown Act Teleconferencing Rules

Board members may attend remotely for "just cause" or due to "emergency circumstances". Certain legal requirements must be met, and members may attend remotely a limited number of times per year.

- For *just cause*, the member must notify the board/committee before or at the start of the meeting providing a general description of the following: 1) caregiving obligations, 2) contagious illness, 3) disability, or 4) travel on official public business.
- For *emergency circumstances*, the member must submit a short description of the physical or family medical emergency, and the board/committee must take action on the request at the meeting. It must be approved by majority vote. The requestor may not vote.
- The board/committee must provide a two-way audiovisual platform and the member must participate through both audio and visual technology.
- The board/committee must provide notice of how the public can access the meeting and offer comments.
- A member must disclose whether individuals at least 18 years old are in the room.
- At least a quorum must participate in person.
- Remote option limited to two meetings per individual per calendar year, and a member may not use this option more than three consecutive months or 20% of meetings.
- All votes must be taken by roll call.
- The agenda need not be posted at the remote location, include the address of the remote location, or provide for public access to the remote location.
- If there is a disruption to the meeting broadcast or in the ability to take call-in or internet-based public comment, no further action can be taken on agenda items until the issue is resolved.

Traditional Brown Act Teleconferences Rules

A board/committee member may still meet via teleconference by following the traditional Brown Act rules of identifying the teleconference site on the ACWDB's agenda and ensuring it is accessible for the public to attend.

NOTE: Beginning January 1, 2026, only the traditional Brown Act teleconference rules will be available.

ACWDB staff have been informed that the standard meeting room now includes updated technology that will support a hybrid meeting in compliance with AB 2449. Staff have solicited training on the use of the updated system – and anticipate being fully prepared for hybrid meetings beginning in 2024.
